**EMBRYO TRANSFER CONTRACT**

**-Embryo Recovery at ERC-  
(Option 3)**

**Equine Reproduction Concepts agrees to the following:**

1. Attempt recovery of embryos from the donor mare, \_\_\_\_\_ Age: \_\_\_\_\_  
Breed: \_\_\_\_\_. The embryo(s) considered suitable by Equine Reproduction Concepts will be transferred to the reproductive tract of the mare owner's recipient mare(s), \_\_\_\_\_.
2. Reserve the right to discontinue embryo transfer attempts at its discretion.

**The Mare Owner or Lessee, \_\_\_\_\_, agrees to the following:**

3. Pay Equine Reproduction Concepts a \$2,250 entry fee at the signing of this contract. This nonrefundable fee covers the \_\_\_\_\_ embryo transfer season, February 20 through October 1.
4. Deliver the donor and recipient mare to Equine Reproduction Concepts.
5. Pay **\$25.75/day\*** (\$27.75/day\* for mares with foals) board fee for the donor mare and the recipient mare(s).  
\*(includes up to 6 flakes hay + 6 lbs of pelleted or textured feed per day. Additional amounts or specialty feeds will be charged at cost.)
6. Pay all charges incurred for shipment of semen and containers, as well as pay all charges for veterinary and other services associated with care of the donor and recipient mare. Routine teasing and palpation of the donor and recipient mare, and insemination (additional \$295/cycle for frozen semen) and embryo recovery attempts of the donor mare are covered by the entry fee.
7. Pay \$1,750 for the transfer procedure of an embryo from the donor to the recipient mare. This fee covers up to three transfer attempts from the same donor mare during the same year only. This fee does not cover pharmaceuticals given at the time of the transfer or post transfer. This only applies to one donor mare for a single pregnancy. Mare owner understands that Equine Reproduction Concepts offers no live foal guarantee when a recipient mare owned by the mare owner is used. This is a fee-for-service agreement.
8. Pay all charges in full before removing the pregnant recipient and/or donor mare, unless prior credit arrangements have been made and approved.
9. Be responsible for abiding by all registry rules and regulations. Equine Reproduction Concepts assumes no responsibility in this regard.
10. All accounts are payable within 30 days of billing date. After 30 days from billing date, interest of 1.5% per month will be assessed on the outstanding balance. Equine Reproduction Concepts reserves the right to refuse service when the mare owner/lessee's account is past due. The mare owner/lessee agrees to pay all reasonable attorney fees incurred by Equine Reproduction Concepts in attempting to collect any outstanding balance. The mare owner/lessee acknowledges the lien rights of Equine Reproduction Concepts to sell the donor mare, pregnant recipient mare, and/or subsequent foal at public auction for unpaid fees and charges.
